## **EXECUTIVE ORDER NO. 15, SERIES OF 2024**

AN ORDER CREATING THE LOCAL EL NIÑO TEAM IN THE MUNICIPALITY OF TERESA, RIZAL

**WHEREAS,** PAGASA has been continuously monitoring the developing El Niĥo conditions in the tropical Pacific. Recent conditions and model forecasts indicate the El Niño may emerge in the coming season (June-July-August) at 80% probability and may persist until the first quarter of 2024;

WHEREAS, according to PAGASA, El Niño increases the likelihood of below-normal rainfall conditions, which could bring negative impacts (such as dry spells and droughts) in some areas of the country. However, over the western part of the country, above-normal rainfall conditions during the Southwest monsoon season (Habagat) may also be expected;

**WHEREAS**, DILG issued Memorandum Circular 2023-065 mandating local government units (LGUs) to prepare for the potential adverse effects of El Niño in the country;

**WHEREAS**, the Office of the President orders the creation of El Niño Team to formulate strategies to mitigate the impacts of El Niño in the agriculture, energy, marine, and water resources sectors.

NOW, THEREFORE, I, RODEL N. DELA CRUZ, Municipal Mayor of Teresa, Rizal, by the powers vested in me by the constitution, do hereby create the Local El Niño Team in the Municipality of Teresa and provide its duties and responsibilities to mitigate the impacts of El Niño phenomenon.

**SECTION 1. COMPOSITION.** The Local El Niño Team of Teresa, Rizal should be composed of the following:

## **SECTION 2. DUTIES AND RESPONSIBILITIES.**

- 1. Convene the Local El Niño Team to monitor and evaluate the impacts of El Niño in the Municipality.
- 2. Formulate strategies and plan of actions to mitigate the impacts of El Niño.
- 3. Coordinate and collaborate with different sectors, agencies and stakeholders for the implementation of action plan on El Niño.
- 4. Formulate risk communication plan for the general public.

5. Recommend policy reforms for resolution.

6. Implement and update the existing contingency plans related to the El Niño phenomenon.

**SECTION 3. REPEALING CLAUSE.** All issuances, orders and memoranda issued inconsistent herewith are hereby nullified and/or repealed.

SECTION 4. EFFECTIVITY. This Executive Order shall take effect immediately.
